5 Applicant's Obligations

a) Applicant shall submit all documents and information in English language;

b) Applicant shall enable to take samples or submit samples of the product for the conformity assessment on scheduled date;

- c) Applicant shall always fulfill the certification requirements, including implementing appropriate changes which are communicated to the Notified Body;
- d) If the certification applies to ongoing production, the certified product shall continue to fulfill the product requirements;
- e) Applicant shall make all necessary arrangements for:
 - 1. the conduct of the evaluation and surveillance (if required), including provision for examining documentation and records, and access to the relevant equipment, location(s), area(s), personnel, and client's subcontractors,
 - 2. investigation of complaints,
 - 3. participation of observers, if applicable;
- f) Applicant shall make claims regarding certification consistent with the scope of certification;
- g) Applicant shall not use its product certification in such a manner as to bring the Notified Body into disrepute, and shall not make any statement regarding its product certification that the Notified Body may consider misleading or unauthorized;
- h) Upon suspension, withdrawal, or termination of certification, the applicant shall discontinue its use of all advertising matter that contains any reference thereto and shall take actions as required by the certification scheme (e.g. the return of certification documents), and shall take any other required measures;
- i) If applicant provides copies of the certification documents to others, the documents shall be reproduced in their entirety;
- j) Applicant shall comply with all requirements prescribed in the certification scheme relating to the use of marks of conformity, and on information related to the product;
- k) Applicant shall keep a record of all complaints made known to it relating to compliance with certification requirements, make these records available to the Notified Body when requested, take appropriate action with respect to such complaints and any deficiencies found in products that affect compliance with the requirements for certification, and document the actions taken;
- l) Applicant shall inform the Notified Body, without delay, of any changes that may affect its ability to conform with the certification requirements (e.g. the legal, commercial, organizational status or ownership; modifications to the product or the production method` contact address and the production sites` major changes to the quality management system).
